**SNOW REMOVAL & SALTING SERVICE
NEEDED FOR WINTER 2023-2024**

DUTIES:

- Remove snow from the following areas:
 - Town Hall front and back stairs
 - Sidewalk starting from the back of Town Hall continuing past Stanton Hall to where it ends on Route 20.
 - Stanton Hall front stairs (11/30 to 1/19 or when ramp is completed)
 - Sidewalk in front of Stanton Hall and Town Hall (facing Route 20) (11/30 to 1/19 or when ramp is completed)
 - Town Hall and Stanton Hall ramp (1/19 or when ramp is completed to 5/1)
- Salt (provided by the town) the following areas:
 - Town Hall front and back stairs
 - Stanton Hall front stairs (11/30 to 1/19 or when ramp is completed)
 - Town Hall and Stanton Hall ramp (1/19 or when ramp is completed to 5/1)
 - Sidewalk in back of Town Hall and Stanton Hall (approx. 60 feet)
- Snow removal and salting must be done by 8:00 a.m. on weekdays. Weekends are flexible unless there is an event scheduled.

MINIMUM QUALIFICATIONS:

- Must be reliable
- Must have own snow removal equipment

COMPENSATION:

- Quotes must be provided at a per clean up rate
