- 1. Please complete all blanks above if they are not already completed.
- 2. Dogs are required to be licensed in the town within thirty (30) days of being acquired or turning six (6) months of age in accordance with Massachusetts General Law Ch. 140, S. 137a*
- 3. Please **provide dogs' current rabies certificates**. The certificates will be returned with your dog tags, **only if requested**. If a rabies certificate is required but not included, **a license cannot be issued**.
- 4. You may license your dogs by appointment during regular Town Clerk hours, but mailing to the above address, or dropping all materials into the large black Town Clerk mailbox at the back of Town Hall, is encouraged. Please enclose a **self-addressed STAMPED envelope** (the post office has requested that **2 STAMPS** be used due to the bulk of the tags). **If a self-addressed stamped envelope is not included, this application cannot be processed.** Licensing fees are listed on the other side on the Dog Census page.
- 5. Please make your check payable to Town of Huntington. DO NOT MAIL CASH!
- 6. Licenses expire annually on June 30th. A **late fee of \$20.00 per dog <u>plus the licensing fee</u>** will be charged for applications received after July 30th, if your dogs were in town and you failed to license them. Applications are not required to be mailed out. Dog owners are responsible for licensing their dogs in a timely manner. No tags will be issued until prior year(s) have been paid in full. Everyone with more than three (3) dogs is required to have a Kennel License. Commercial kennels are required to have a Business License as per MGL and a Special Permit as per the Town's Zoning Bylaw.
